### "A shared understanding of urban development in Europe"

"In terms of aims, objectives, and values, there is an explicit agreement at European level on the character of the European city of the future and the principles on which an ideal European city should be based...There is also a consensus among the ministers responsible for urban development on more specific city objectives and values - as reflected in the Leipzig Charter – as well as how these objectives should be attained and the instrumental role cities can play in implementing Europe 2020 as expressed in the Toledo Declaration. The same goes for the principles of urban development in the European territory as expressed in the Territorial Agenda of the European Union 2020."

#### Cities of tomorrow

Challenges, visions, ways forward



European cities should be

- places of advanced social progress;
- platforms for democracy, cultural dialogue and diversity;
- places of green, ecological or environmental regeneration; and
- places of attraction and engines of economic growth.
- European urban territorial development should
- ✓ reflect a sustainable development of Europe based on balanced economic growth and balanced territorial organisation with a polycentric urban structure;
- contain strong regional centres that provide good accessibility to services of general economic interest;
- ✓ be characterised by a compact settlement structure with limited urban sprawl; and
- ✓ enjoy a high level of protection and quality of environment around cities.



# Big Picture: Europe 2020 targets

Strategy for "smart, sustainable & inclusive" growth models.

- Employment: 75% of 20-64 year-olds
- R&D: 3% GDP investment
- Climate: Emissions -20%; RES = 20%; EE +20%
- Education: NEETS >10%; 40% of 30-34 yr-olds HEI qualified
- 20 million fewer in poverty

Frames every (non-crisis related) EU action/decision – incl funding.

Influence on MS policy: Annual NRP (progress & planned measures). ...LA sector input and sub-national consideration in IE's case?

Europe 2030 etc?

Which (of 5) option for *'the Future of Europe'?* What place for Cohesion Policy...or cities (within/beyond)?



### The Urbanising EU

- First EC 'Towards an Urban Agenda' paper, 1997
- ESDP 1999: Polycentricity; less hierarchical; more functional.
- 70% of EU legislation implemented local/regionally direct impact.
- Tackle social challenges and realise growth potential (*Europe* 2020 targets reliance).
- Momentum behind need to better ...link urban solutions with EU challenges; target EU funding accordingly; adjust sectoral policies and levels of governance; assess territorial impacts.
- Gradual rise in scope of EU policy interventions in urban settings.
- Cohesion Policy\*...increasingly urban-focussed.
- Urban development <u>not</u> an EU competence (no treaty basis).
- Discussions primarily intergovernmental... variable MS intensity.



### Pact of Amsterdam (2016)

"The Ministers affirm that [The Urban Agenda for the EU]:

- 1) ...aims to realise the full **potential and contribution of Urban Areas** towards achieving EU objectives and related national priorities (...subsidiarity and proportionality).
- 2) ...strives to establish a more effective *integrated and coordinated approach* to EU policies and legislation with a potential impact on Urban Areas and also to contribute to *territorial cohesion by reducing socio-economic gaps*.
- 3) ...strives to involve Urban Authorities in design of policies, to mobilise them in implementation, and to strengthen the urban dimension in these policies...overcome unnecessary obstacles in EU policy to enable cities to work in a more systematic and coherent way towards overarching goals... make EU policy more urban-friendly, effective and efficient.
- 4) ...will not create new EU funding sources, unnecessary administrative burden, decision-making structures, EU competences."





Core objective: to improve the implementation of EU and national policies on the ground, by involving cities in the design and implementation of urban-related policies as a way of making them more effective, efficient and inexpensive.

Horizontal & vertical coordination plus integrated actions (EU level)

3 policy-making and implementation pillars:

- To look at how existing rules and regulations can be adjusted to become more urban-proof ('better regulation');
- To improve use of existing EU financial instruments ('better funding');
- To improve current data exchange networks ('better knowledge').



## Cross-cutting UAfE aspects

- Governance (incl metropolitan, functional, urban-rural and interurban) and stakeholder relations (civil society, business...);
- Sound and strategic planning and balanced territorial development (links with regional level);
- Integrated approaches;
- Innovative approaches;
- Impact on societal change;
- Small/medium cities;
- Urban regeneration;
- Demographic change;
- Public services of general interest (availability and quality);
- Links with UN (Habitat III *New Urban Agenda* and 2030 SDGs.




### 12 Priority themes



- support by Member States, EC and cities;
- To reflect major challenges faced by cities;
- require integrated action at EU-level and multi-level cooperation;
- potentially produce concrete results in a reasonable timeframe.







### Multi-level Partnerships

- Agenda to be taken forward by 12 multi-level "partnerships"
- Membership based on topic expertise. First 8 are underway.
- Each will prepare and implement an Action Plan with concrete proposals for actions at EU, national and local level to be achieved within 3 years (to be followed-up under future EU Presidencies).

- Late 2017, progress report to Council with suggestions for improvements and future direction of EC urban policy.

HOUSING

Adequate housing is a basic human right and plays a key role in ensuring a good quality of life in European cities. Although a competence of national, regional and local governments, several EU policies and regulations have an impact on how housing policies can be formulated. housing affects social cohesion and stability; many challenges need to be addressed such as post-crisis development, increased migration and growing social tensions. More affordable and healthier homes are needed also, as well as a better energy efficiency in buildings. Together, we can develop a comprehensive framework for the provision of affordable housing.

The Housing Partnership will improve knowledge regarding social housing and other affordable housing models in Europe, looking into different systems both from the consumer and producer perspectives. Models of financing will be explored and current EU legislation, policies and instruments with an impact on housing policies will be reviewed. In the Action Plan the Partnership will identify actions to tackle agreed priority themes and to specify first concrete steps to be implemented.




