

The Arrival Cities Project is now entering its final year. Drawing on the transnational programme network partners are discussing deeply the development of their LOCAL ACTION PLANS. Furthermore on the 23-26 May 2017 took place in Thessaloniki the 3rdTransnational Workshop and 5th SGM of the project, which have seen the participation of more than 30 persons among delegates and project staff members along with URBACT representatives. The workshop has also seen a collaboration with students from the Masters programme of Sciences Po university from Paris who joined delegates from Arrival Cities during the visits to the reception centres and brought an added value to the exchange through the wide range of disciplinary practices they are following.

WE INTRODUCE OUR NETWORK PARTNERS



Roquetas de Mar is one of the cities participating in the ARRIVAL Cities Project. Its inhabitants come from over 100 different countries and it is the sixth Andalusian city (over 50.000 inhabitants) with a higher percentage of foreign born citizens a 28.38%.



Thessaloniki is the second largest city in Greece and the capital of the region of Macedonia. Thessaloniki is the major commercial port and economic hub for northern Greece. More than 25,000 people living in Thessaloniki are migrants, making up about 8% of the city population.
