

Boosting Social Innovation

The aim of the project was to exchange knowledge and best practices to boost social innovation in cities and to design a local innovation social plan, focused in different policies, according to every city particular priorities.





01. Call for proposals.

March 2015: call for the creation of up to 20 Action Planning networks. Barcelona Activa was invited to take part in the second phase of the network. The first phase's partnership was constitued by:

- City of Gdansk
- City of Braga
- City of Turin
- City of Milan

The project proposal was linked to the following objective:

1. Promoting Integrated Sustainable Urban Development

1.1. Disseminating good practice and expertise and capitalising on the results of the exchange of experience in relation to

sustainable urban development, including urban-rural linkages

1.1.2. To improve the design of sustainable urban strategies and action plans in cities





02. Preparation-decision.

The city of Turin visited Barcelona Activa and detected many synergies that both cities considered working together made sense for both of them and for the other members of the partnership.

The rationale behind Barcelona Activa's decision was:

- Alignment with the project proposal's aims.
- Momentum: Barcelona Activa was about to implement Economic Development Plans Strategy and it needed a strategy to plan this process.
- Partnership: there were big cities that had could have complementary challenges with Barcelona, such as Paris, Milan and Turin.
- Funding: European funds are considered as a complement for a budget you had already devoted to your project idea.
- Transnational dimension: the interchange of ideas with other realities must make sense for all the partners. Being a free ridder is not an option.
- Role of the lead expert: knowledge, intellectual inputs, partnership coherence.
- Political will and engagement: essential.



03. Project development

Common approach

- Shared methodology
 - Need to co-create policies with the population.
 - Periodical meetings and study visits
- 21st century cities challenges:
 - Migration
 - Launching of new economic sectors
 - Inequal access to resources from the population

- Gdansk: crosscutting social innovation plan
- Paris: circular economy
- Wroclaw: revitalization of a deprived commercial street
- Barcelona: economic development plans strategy
- Turin: crosscutting social innovation plan
- Milan: accelerating Milan's local ecosystem for social innovation
- Skane: intersection between culture and social innovation.
- Braga: youth policies
- Baia Mare: culture as an economic engine




