The RU:RBAN project

In the second phase of the URBACT Program, Rome exports good practices of urban regeneration and proposes models of redevelopment and social inclusion to France (city of Caen), Greece (city of Thessaloniki), Lithuania (city of Vilnius), Poland (city of Kraków), Portugal (city of Loures) and Spain (city of A Coruña). This is the mission of the RU:RBAN project, which has been awarded funding of \in 600,000 by the European Territorial Cooperation framework for sustainable and integrated urban development. The First Trans National Meeting in Phase 2

The delegations of the 6 partner cities have come to Rome for the first multi-event meeting which took place on February 19-21. The aim of this kick-off meeting was to identify, together with stakeholders and other actors involved in the project, the actions to export integrated redevelopment models.

At the international venue of the Casa della Città (City House), 25 people participated in the sessions of Day 1, dedicated to the RU:RBAN Roadmap and to the Transfer Travel of Phase 2.

The partners presented their ULG formulation and ULG meeting results while the NE Konstantinos Karamarkos showed the Methodology Outline & Outputs.

A Fine-tuning on Management aspects and on Communication & Dissemination issues and tools closed the first day. According to **Claudio Bordi**, Rome URBACT Local Group Coordinator, "The challenge is to succeed, by the end of the URBACT journey, to make the dialogue between the members of the URBACT Local Groups of the different countries sustainable and to encourage the exchange of experiences and knowledge in order to improve the governance of the processes related to urban gardens in all the cities involved in the project".

Day 2, dedicated mostly to project elements E1 -Capacity Building and E3 - Governance, had 42 people attending.

The highlights of the day were a very successful Capacity building workshop conducted by **Silvia Cioli** (Urbact Ad hoc Expert), which resulted in an extremely interesting exchange of experiences between Rome ULG members and the representatives from the partner cities, and the Peer Review Methodology session conducted by the **Konstantinos Karamarkos** (Urbact Lead Expert) and **Fiammetta Curcio** (Urbact Ad hoc Expert).

A detailed overview of the Rome Regulation of Urban Gardens by **Paola Marzi** (City of Rome Officer, Head of Urban Gardens Office) concluded the workshop while keeping in mind that "Working in a Community Garden is a starting point, not a point of arrival..." (Filippo Cioffi, Rome ULG member).



On **Day 3** ULG members and partner cities representatives moved to the venue of Sala Libera at the Risorse per Roma headquarters for the session dedicated to project element E2 (Vocational Training). The Training Expert **Andrea Messori** led many complex and challenging workshop activities targeted to provide training in the profession of "gardeniser" through a learning by doing process. 25 people participated in the very demanding session. What is a gardeniser?

A warm welcome from the city government was addressed by Carlo Cafarotti, Councillor for Economic Development, Tourism and Labour of Roma Capitale: "For the second time Europe nominates us 'resilient urban agriculture city'. We are proud to export abroad our good practices of
