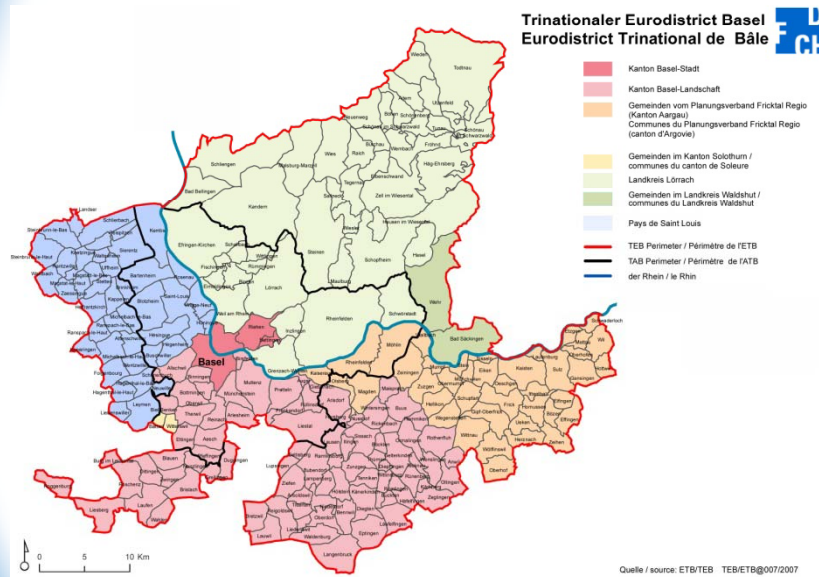


Presentation of the Trinational Eurodistrict Basel (TEB)

- 830 000 people live in the 226 municipalities of the TEB



Presentation of the Trinational Eurodistrict Basel (TEB)



- Its territory extends over an area of 1.989 km² in France, Switzerland and Germany



Presentation of the Trinational Eurodistrict Basel (TEB)

- The territory of the Eurodistrict is already strongly integrated at a functional level – some 60 000 international commuters cross the borders on their way to work every day





History of the cross-border co-operation in The Trinational Eurodistrict Basel (TEB)

- European cross-border cooperation first emerged in Basel in 1963 when the Regio Basiliensis was established.
- The cross-border cooperation on the level of the conurbation started in 2001 with the launching of the Trinational Conurbation Basel (TAB) project.
- With the creation of the Eurodistrict in 2006, the French, German and Swiss political authorities have decided to strengthen their cooperation on the conurbation level. This has been done on the basis of the TAB association.





Current cross-border governance in the Trinational Eurodistrict Basel

The TEB is an association which has three political and a variety of technical bodies :

- The **assembly** comprises representatives of all the members of the association.
- The **management committee** heads the association. This consists of eight German, eight Swiss and eight French members
- The **Consultative council** consists of 20 Swiss, 15 French and 15 German members.

The association has two technical bodies

- The technical coordination committees
- The technical secretariat with four full-time staff

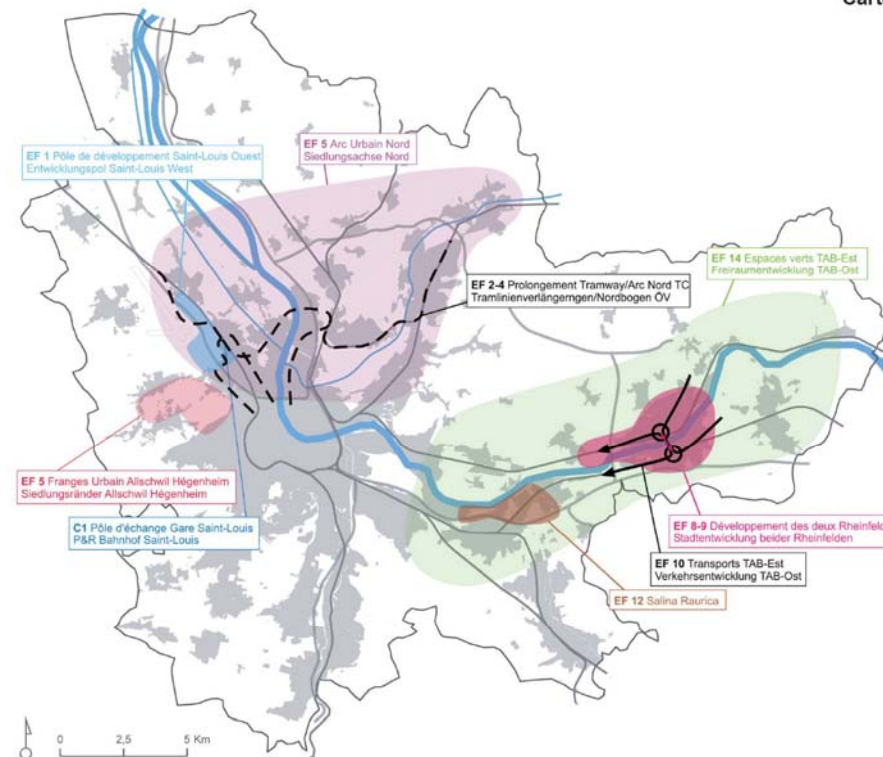


Current cross-border governance in the Trinational Eurodistrict Basel

- Other fields will follow.



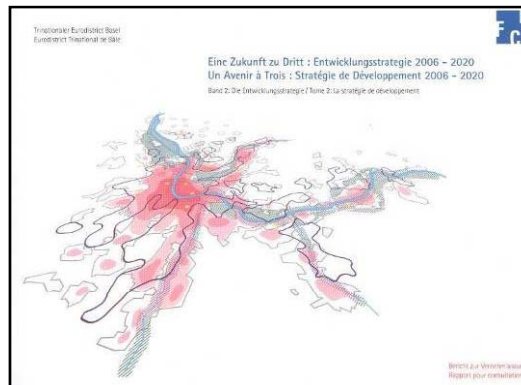
Perspectives
