# Project objectives and detailed working programme for phase II








### The main objective of this network is the elaboration of working programmes and policy recommendations for improving the cooperation between cities and their surrounding municipalities


### The main challenges include:





# Workshop design and methodology

- 1. Each hosting city should find a local / regional / national expert on the specific topic of the workshop in its city (if this is not possible, the Lead expert will propose an expert).
- 2. The Lead expert or thematic expert gives a general introduction on the specific topic of each workshop.
- 3. Each partner provides inputs (existing studies, documented best practices, documented pilot projects, etc.) for the specific topic of each workshop on basis of pre-defined questions.
- 4. Each partner shortly presents the results of the meetings of the LSG and their recommendations for the network.
- 5. Each hosting city invites its Managing Authority and also each partner can take one representative of its Managing Authority to the workshop which is of the most interest for its city.
- 6. Beginning with the 2nd workshop 2 cities present their main challenges (main problems to be solved within the network, description of areas of interventions, etc.) and therefore their main contents for their individual LAP. Common solutions should be found during the workshops.
- 7. The Lead expert will summarize all the results of each workshop and present them during the next workshop.

# **Recommendations from the EAP**

### Criterion 1 – Relevance of the Proposal and EU Added Value

The theme of this project is of high relevance and is innovative Following previous EAP recommendations, the project now includes several concrete topics related to the question of managing metropolitan areas EAP feels that the project is heavily focussed on tools, and it would be useful to place a stronger emphasis on methods of governance

### **Criterion 2 – Coherence of the Proposal**

The project is coherent and outlines clear results.

Some of the outputs could however be clarified, by explaining the target groups of the different types of meetings and conferences.

### **Criterion 3 – Quality of Expected Results**

Outputs and deliverables are coherent, but some elements require clarification. The project is organised around several types of meetings, seminars and conferences. In order for these events to create a dynamic and useful exchange however, it would be important to provide further detail on their main objectives and concrete outputs.





# **Recommendations from the EAP**

### **Criterion 4 – Quality of Partnership and Lead Partner**

The partnership is geographically balanced, but given the relatively low number of current partners (8+LP) there is scope for extension, perhaps to a city from Northern Europe. <u>(Tallinn Estland or Vilnius Litauen as possibilities)</u> The Local Support Groups are generally well balanced, however some could

include associations of municipalities.

### **Criterion 5 – Budget and Finance for Implementation Phase**

The budget is balanced and coherent.

### **Comments on Communications Plan**

The Communication plan is very good and fulfils the demands.

### **Concluding remarks**

This project addresses an important topic. The EAP's previous recommendations have fully been taken into consideration, and as a result the project has become more operational, integrating more aspects of the urban management of metropolitan areas. It is still suggested to put more emphasis on the operational side of the proposal, and to consider how the different tools can be put into practice. The extension of the partnership would be useful.

Local Action Plans are a new dimension to the URBACT programme:


- •Improve the impact of transnational exchange and learning on local


# **Cohesion Policy and cities**

The Community Strategic Guidelines 2007-2013 pay particular attention to specific needs of certain zones, such as urban and rural areas.

Europe is characterized by a polycentric structure of small, medium-size and large towns. Many of them form metropolitan areas while many others constitute the only urban centre in the region.

European cities attract investment and jobs. They have many tools at their disposal to strengthen their attractiveness. The proposals of the Commission for Cohesion Policy contain many elements able to support these initiatives At least four key issues require attention:

- Transport, accessibility and mobility
- Access to services and amenities
- Natural and physical environment
- Cultural issues





# **Cities and regions**

Requirements from the EU:

- Flexible co-operation between the different territorial levels
- Cities must find forms of governance which respect the institutional organisation of each Member State
- Cities can make use of technical assistance from the Structural Funds.
- Skills in new areas often working across traditional professional boundaries are particularly important

"In conformity with the General Regulation on Structural Funds, the Member States have the possibility of delegating to cities funds addressing urban issues within Structural Fund Operational Programmes. To get the full benefits of partnership, cities must be responsible throughout the process. This includes responsibility for the design and implementation of the subdelegated portion of the programme."





# Sustainable urban development

### Sustainable urban development

Urban development is a complex process. Cities should integrate this development in a long term perspective to maximise the factors of success

### Citizen participation


Citizen participation is a democratic imperative - the engagement of local residents and civil society in urban policy can give legitimacy and effectiveness to government actions

### Networks and exchange of experience

Skills and knowledge are an important precondition for urban regeneration. Successful solutions often require specific competences, including cooperation across administrative or professional boundaries

#### Financing Urban Renewal

In the framework of the new regulations for the ERDF, the Cohesion Fund and ESF, the managing authorities of operational programmes will be able to finance a wide range of urban development projects
