Operational Programme:

Increasing regional competitiveness and inclusive urban development in Vienna 2007 to 2013







Cornerstones of the OP Vienna

Adoption of the OP by the **Vienna Provincial Government** on 9 September 2006

→ Review on the basis of changes proposed by the Commission to be completed by the spring of 2007

Funding: EUR 25 million under the <u>European Regional</u> <u>Development Fund (ERDF), another 25 million euros in provincial funds</u>

Geographically the OP covers

- ✓ the entire province of Vienna;
- ✓ individual activities refer to selected areas of Vienna.


