# URBACT In Focus A shared learning experience

In FOCUS is a network, led by Bilbao, that encompasses ten European cities and metropolitan areas that have developed a shared learning experience over almost three years within the framework of the URBACT Programme to develop integrated smart specialisation strategies.



#### **URBACT – Driving change for better cities**

URBACT's mission is to enable cities to work together and develop integrated solutions to common urban challenges, by networking, learning from one another's experiences, drawing lessons and identifying good practices to improve urban policies. The URBACT Programme is jointly financed by ERDF and the Member States.





# In Focus project Objectives and expected results

The IN FOCUS project brings together cities with experience in **urban economic development** based on sectors or clusters, which wish to deepen the concept of **Smart Specialisation** in order to strengthen its potential for growth and global positioning, establishing a bridge with the RIS3 to regional level through **multilevel governance**.

Making a bridge between RIS3 regions and Cities


As the key result of the project all participating cities have produced an Integrated Action Plan (IAP) in close collaboration with their local stakeholders.



## The path towards smart specialisation in Bilbao

With a eye on the Basque Country's RIS3, and based on its specific reality, the City of Bilbao carried out in 2014 a cluster prioritisation exercise at city level, defining the priority areas and sectors for the economic development of the city in the so-called Innovation and Smart Specialisation Strategy of the Municipality of Bilbao.

The Innovation and Smart Specialisation Strategy for Bilbao defined **6 priority sectors or clusters** for the city

# Why an Integrated Action Plan for the specialisation in Bilbao?

Bilbao defined the sectors of opportunity and specialisation of the city, but it was necessary to take a further step, establishing a long-term operative work plan to support the local economic fabric and develop the strategic sectors.

## Within the IN FOCUS framework, the City has gone further in three mutually reinforcing directions:

- Promoting more alignment in policies and working areas, in particular those related to local economic development policies to the Basque RIS3 through best city-region smart specialisation articulation.
- Improving multilevel coordination and collaboration among stakeholders.
- Defining a framework for the development of projects in collaboration in the prioritised sectors.



# A plan co-designed with the local stakeholders The URBACT Local Group

The future of the city must necessarily be built in collaboration with all the socio-economic agents involved in its development, including representatives of the different levels of government (regional, county and local), the field of knowledge and the university, as well as the business fabric and clusters.

The URBACT methodological framework has allowed to involve and work with local stakeholders thanks to the creation of URBACT Local Group (ULG).


In the framework of the project, 8 sessions have been held, during which work has been carried out on key aspects for the co-design of the Action Plan for the smart specialisation of Bilbao.



# Focused on **3 sectors** of opportunity

The Integrated Action Plan is focused on three of the six sectors of opportunity and specialisation defined within the Strategy of Innovation and Smart Specialisation of the city.

In the selection of these three sectors, special attention has been given to their alignment with the strategic priorities of smart specialisation defined at regional level in the Basque Country.





### **6 Action Lines**

to give support to the Smart Specialisation process

Six transversal lines of action have been identified in which it is necessary to work in all sectors, on the main aspects that improve both the competitiveness and positioning of the city to attract talent and projects, as well as the ability to identify opportunities, improve the knowledge, etc.

The lines of action defined to support the specialisation process in the three prioritised sectors, as well as the objectives pursued with each of them are detailed on the next page.

#### **Competitive Intelligence**

Promote the detection of opportunities in the priority sectors of specialisation through the implementation of a process of obtaining and transforming information on these sectors



#### Competitive improvement and development of the priority sectors

Promote, develop and improve the competitiveness of companies in each sector, fostering relationships between them and developing services that impact on the generation of economic activity and employment



#### Entrepreneurship

Boost the creation of new companies that generate economic activity and, therefore, employment in the Municipality, prioritising initiatives in the sectors of opportunity and trying to approximate, both conceptually and strategically, the process to market demands



#### **Attractiveness and Branding**

Contribute to the promotion and visibility of Bilbao as a city linked to the prioritised sectors that favour the attraction of productive investment and talent linked to the priority sectors of specialisation



#### Spaces for the specialisation

Generate places and spaces, physical or not, that bring together strategic agents (public administrations, universities, research centers, businesses) to cooperate and co-produce to face the challenges of specialisation of the city and the priority sectors



#### Talent

Promote the training and capacity building, attraction and retention of the talent necessary to respond to the needs of the priority sectors



# Strategic Initiatives and Flagship Projects

Each of these lines of action is developed through the implementation of a set of **Strategic Initiatives** that directly contribute to some of these transversal lines and bring together different support instruments, as well as **Flagship Projects** that will be carried out in collaboration with public and private agents to boost the priority sectors.


### Governance model for the implementation of the Plan
